III.	Guidance for the Open Meeting Act – Ryan Baker
	12:36pm; Role is to provide legal advice as to business. Subject to Open Meetings
	Act. As per Neb.Rev.Stat. 84-1407. Certain requirements need to be met before
	having a public meeting. Physical sites are mandatory. One commissioner needs
	to be on site. Conferences need to be recorded. Copy of all documents that are to
	be considered. Agenda etc. Open meeting statute has to be present at the

meetings as well as virtual. 1/2 can be virtual. Hybrid meetings are not

permissible. (Internal policy) Everyone must be present physically. Discretionary to allow public to speak, now its mandatory for public to make comments.

Members of the public can record the meeting and share as they see fit.

Reasonable public notice: Notice of Public Meeting must be made available.

Time of advance notice. 3-4 days is appropriate for notice. Agenda as well must be present. Closed sessions are acceptable but must have a good reason such as information not relevant to the public. Ex: Discussion regarding deployment of security personnel or devices. Voting: any final votes must be public.

Q: Gwen: The rules of meetings and the ethics of meeting.

A: Informal meetings are not permissible if there are commission business being discussed.

Q: Connie: Our Bylaws do not trump the statute and liability of special meeting notices. More than half the meetings have to be physical.

Ryan Answer: 24 hours. Commissioners can't participate during Hybrid meetings. Recommended to post in the newspaper, but not required.

Ryan: Not specified by statute regarding meeting participation by commissioners.

Will not be getting credit for the parking. Morehouse sent 50k but only received 25k. Budget analysis. To date have not used funds and will need to discuss. Tony Clarke denied payroll. Previous chair promised to contribute to Juneteenth. The full commission must approve funds over 2,500.

Gwen stated that she does not approve of the financial committee report because actions were taken.

The commission did agree to hire an administrative assistant.
